

THE AFRICAN FOREST FORUM (AFF): Goal and programmatic approach

Goal

To provide independent analysis and advice to national, regional and international institutions and actors, on how economic, food security and environmental issues can be addressed through the sustainable management of forests and trees





The project

Strengthening management and use of forest ecosystems for sustainable development in Africa (AFF-Sida)

The overall goal: "to generate and share knowledge and information through partnerships in ways that provide inputs into policy and decision-making options and capacity building, for improved forest management that better addresses poverty eradication and environmental protection in Africa".



Specific objectives include:

☐ Identifying and promoting opportunities for protecting and sustainably managing the forest resource base on the continent as well as the supply of its ecosystem goods and services

Contribution of this WS to project's outcome: Outcome 1.3:

☐ Stakeholders, by gender, in African forestry capacitated to sustainably manage the forest resource base in ways that enhance the supply of ecosystem goods and services



AFF facilitated a study on "Assessment of forest planning and management in different forest types in selected African countries"

The purpose of the study is to evaluate ways for improving forest planning and forest management in selected countries in Anglophone and Lusophone Africa with the aim to enhance the supply of forest ecosystem goods and services.

Study covered <u>28 Anglophone and Lusophone countries</u> (secondary data). Field work was conducted in selected forests in <u>four countries</u> (Angola, Tanzania, Zambia and Zimbabwe).









Specific objectives of the study:

On forest planning:

- a) Evaluate the **planning processes** found in forest types in the selected countries and;
- b) Evaluate the adequacy of the plans in terms of:
 - √ accuracy / reliability and adequacy of information used,
 - ✓ tools / techniques / models used for planning and for moving the forest to a desired future structure,
 - ✓ adequacy of knowledge and skills for their development,
 - ✓ sensitivity to gender considerations,
 - ✓ inclusiveness of related sectors,
 - ✓ constraints in planning and ways to contain them.









Specific objectives of the study:

On forest management:

- a) Evaluate institutions implementing forest management;
- b) Assess human, financial and physical resources available for forest management;
- c) Assess the extent of compliance to plans by implementing institutions, constraints experienced and how to overcome them and;
- d) Evaluate the **state of management of the forest** types in the selected African countries.









Key results of the study:

On forest planning:

- ☐ Most of the plans are not based on recent national forest inventories;
- ☐ Most plans reflect low knowledge and skills employed in their development;
- ☐ Constraints to forest planning include inadequate financial, human, and technical capacity;
- ☐ Overdependence on donor support;
- ☐ Institutional and administrative constraints;
- ☐ Inadequate and inaccurate information.









Key results of the study:

On forest management:

- ☐ The chain of decision making is long: most common level of subordination was three: two levels between the minister and the FM unit
- ☐ Percent of female staff: 3% 45%.
- ☐ Percent of degree holders among staff: 0.7% 53.5%.
- ☐ Expenditure in forest management is a few dollars per hectare per year
- ☐ Most of the planned activities for forest management are not fully implemented (in progress)
- ☐ Institutional, human capacity and financial constraints









Recommendations from the study

- Countries should own forest planning to maintain their sovereignty.
- ☐ Stakeholder awareness should be enhanced to ensure they know and play their roles.
- ☐ Forest plans should give gender proper considerations.
- ☐ Forest plans should include longer terms than 5 years as well as shorter term 5-year plans.
- ☐ Forest plans should be based on recent forest inventory and analysis of demand and supply of forest products.
- ☐ Governments should commit more resources to forest planning.

There should be training to improve the knowledge and skills for forest planning.









Highlights of discussions on the forest planning and management during the information sharing workshops

- Weak intersectoral coordination in planning and management of forestry resources affects the productivity of land.
- Land restoration and afforestation efforts required informed planning with adequate data and information.
- There is need to strengthen forest certification schemes for African forestry to promote SFM across the board.
- Governance is an important factor in effective forest management.

Strengthen the capacity of the African forestry stakeholders to improve forest planning processes and best practices in forest management

Specific objectives

- ☐ To equip the forestry stakeholders with information and tools to formulate forest plans for different forest types.
- ☐ To equip the forestry stakeholders with tools and skills for undertaking activities related to forest management in different forest types.
- ☐ To provide an opportunity for African forestry stakeholders from different countries to meet and exchange lessons and experiences on forest planning and forest management processes
